

### Measures and documentation of infection control under COVID -19

Flåm Bilutleie AS follows the guidelines of the authorities regarding COVID -19:

This means that among other measures, an even greater focus on the hygiene and cleaning of the busses will apply. Surfaces inside the vehicles will be washed and disinfected frequently.

Frequent affected areas of the busses will be disinfected by personnel after each trip. Other surfaces in the bus will be cleaned as often as practicable.

In case of driver change, the driver's seat and the cockpit will get cleaned / disinfected.

Flåm Bilutleie AS is operating in accordance with the restrictions and regulations of the Norwegian Government's Health Department to reduce risk for infection. The passenger capacity per transport unit and the hygienical measures are based on the national level of action for reduction of contagiousness:

<b>Red level</b>	Extended contact reducing measures  50% capacity  7 Pax in minibus 28 Pax in coach	In addition to green and yellow level measures: <ol style="list-style-type: none"> <li>1. Contact reducing measures: <ul style="list-style-type: none"> <li>- 1m distance between each passenger obligated</li> </ul> </li> </ol>



When operating under yellow or red level of action the seats that will not be used are going to be blocked / marked.

Hand disinfection is available and mandatory to use by all passengers when entering the bus.
